

Fallout® 4 Xbox® One Scavenger Hunt Sweepstakes

OFFICIAL SCAVENGER HUNT AND SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. **Fallout® 4 Xbox One Scavenger Hunt** (the “Scavenger Hunt”) and **Sweepstakes** (the “Sweepstakes”) is sponsored by Bethesda Softworks LLC (the “Sponsor”). For the purposes of the Sweepstakes, the “Sweepstakes Group” is composed of the Sponsor, together with its affiliates and related companies, including without limitation its parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Sweepstakes, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Sweepstakes and their respective officers, directors, employees, agents, and other representatives.

1. SWEEPSTAKES PERIOD

The Sweepstakes starts on **Monday, October 26th, 2015 at 12 p.m. EST** and ends on **Monday, November 2nd, 2015 at 8:59 a.m. EST** (the “Sweepstakes Period”).

2. ELIGIBILITY

All participants must be 18 years of age or older at the time of entry, must possess a valid form of identification and be a legal resident of one of the 50 United States (or the District of Columbia) excluding the territories, military installations and commonwealths. All applicable federal, national, state, provincial and local laws and regulations apply. Void where prohibited, restricted or taxed by law. Excluded from eligibility are officers, directors, employees, agents and representatives of Sponsor, each of its respective parent, affiliated or related companies, agencies, suppliers of the materials and services related to this Sweepstakes, and members of any immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of such officers, directors, employees, agents and sales representatives.

3. HOW TO ENTER AND WIN THE SCAVENGER HUNT

NO PURCHASE NECESSARY. Enter by locating the S.P.E.C.I.A.L. Vault Boy bobblehead in the Daily City announced by Sponsor and completing the Daily Scavenger Hunt Objective:

At approximately 6 p.m. EST each night before each day of the Sweepstakes Period, the Sponsor will make posts from its @bethesda Twitter account announcing the U.S. city where the Scavenger Hunt will take place on the following day (each, the “Daily City”).

Each day at approximately 10 a.m. local time the Sponsor will tweet a message on its @bethesda Twitter account (the “Daily Clue”) that includes (i) a clue that directs participants to a location within the Daily City, (ii) a picture of a S.P.E.C.I.A.L. themed Vault Boy bobblehead, and (iii) #VaultBoyTour (“Hashtag”).

To enter, find the S.P.E.C.I.A.L. themed Vault Boy at the location referenced in the Daily Clue and recite (verbally or in writing) the Hashtag to Sponsor’s representative stationed at such location (“Daily Objective”). The first person to complete the Daily Objective that fulfills the eligibility requirements set forth in Section 2 above will be the Scavenger Hunt winner for such day (the “Daily Scavenger Hunt

Winner”). See Prize Claim Conditions in Section 6 below. Selected entrants in the Sweepstakes are not eligible to win the Scavenger Hunt.

4. HOW TO ENTER THE SWEEPSTAKES

NO PURCHASE NECESSARY. Enter via Twitter: Internet access and Twitter account required.

Each day during the Sweepstakes Period, Sponsor will send a Tweet via its Twitter account announcing the Daily Scavenger Hunt Winner for that day (the “Scavenger Hunt Tweet”). To enter the Sweepstakes, log into your Twitter Account and “Follow” @Fallout and @Xbox. Then, retweet the Scavenger Hunt Tweet using the Hashtag prior to 8:59 a.m. EST the following day to receive one (1) entry into the Sweepstakes. In order for your entry to be valid, your Twitter Account must be public and thus viewable by the Sponsor and its agents.

Once your submission is received, you will receive one (1) entry (each an “Entry” or collectively, the “Entries”) into the Sweepstakes. By submission of an Entry, you confirm that you have read, understood and agree to abide by these Official Scavenger Hunt and Sweepstakes Rules. You must satisfy the eligibility requirements listed in Section 2 above or your submission will be void and ineligible for entry into the Sweepstakes. You represent and warrant that your submission is not libelous, defamatory, profane or obscene and does not infringe upon the intellectual property rights, rights or privacy or personality or any other statutory or common law rights of any other person. Limit: One (1) Entry per person per day during the Sweepstakes Period. Entry must be submitted by the entrant him or herself. Daily Scavenger Hunt Winners are not eligible to enter the Sweepstakes. If entering via Twitter, entrant may only use one (1) Twitter account in connection with this Sweepstakes. Any attempt to exceed the maximum number of Entries per person is a violation of these Official Scavenger Hunt and Sweepstakes Rules and may result in disqualification. Use of automated devices is prohibited; automated Entries (including but not limited to Entries submitted using any robot, script, macro or other automated service) are not permitted and may result in disqualification.

5. HOW TO WIN THE SWEEPSTAKES

On or about **9:00 a.m. EST** each day between Tuesday, October 27th, 2015 and Monday, November 2nd, 2015, a random draw will be conducted from all eligible Entries received via Twitter since the previous day’s Scavenger Hunt Tweet was posted (the “Draw Dates”). See Prize Claim Conditions in Section 6 below. Odds of being selected as eligible to win a prize in this Sweepstakes will depend on the total number of eligible Entries received each day during the Sweepstakes Period.

6. PRIZE CLAIM CONDITIONS

Daily Scavenger Hunt winners will be notified at the time they complete the Daily Objective and will receive their prizes when notified or if prizes are unavailable, Sponsor will mail the prize to the mailing address provided by winner(s). The selected entrants in the Sweepstakes will be notified by Sponsor within approximately forty-eight (48) hours of the respective Draw Date(s) via the Twitter account used by the entrant to submit the Entry. Daily Scavenger Hunt Winners and the selected entrants in the Sweepstakes may also be required to complete and return to Sponsor (or its authorized agent) by the deadline specified in the documents a written affidavit of eligibility (or declaration and release) and

publicity release form (collectively, the “Release”), releasing the Sweepstakes Group from any liability in connection with this Sweepstakes or the acceptance, possession, use or misuse of any prize. Return of any prize or winner notification as undeliverable, inability to reach selected entrant or failure of selected entrant to respond to notification within three (3) days of first attempt by Sponsor or Sponsor’s agent, failure to provide proof of eligibility (if requested), Release documents, or other required documentation in a timely manner, or other non-compliance with these Official Scavenger Hunt and Sweepstakes Rules may result in disqualification, forfeiture of the prize and, at Sponsor’s sole discretion, selection of an alternate eligible entrant for the forfeited prize at random from all remaining eligible Entries received, who will be subject to disqualification in the same manner. With respect to the Sweepstakes the winner of any one drawing is ineligible for another drawing. With respect to the Scavenger Hunt a participant may only win in one Daily City.

7. PRIZES

There will be fourteen (14) winners (7 Daily Scavenger Hunt Winners and 7 selected entrants in the Sweepstakes). Each winner will receive a **Fallout 4 Custom Xbox One**, having an approximate retail value of \$399.00 USD.

The Prizes will be delivered only to verified winners. ARV determined as of October, 2015. Prices are subject to change; retailers may sell for less. Prizes must be accepted as awarded and may not be substituted, transferred or redeemed for cash or otherwise; however, the Sweepstakes Group reserves the right to substitute a prize of equal or greater monetary value, in cash or otherwise, at its sole discretion, if a prize, or any component of any prize, cannot be awarded for any reason. Sponsor will not replace any lost or stolen prizes. Sponsor makes no representations or warranties with respect to any prize. Prizes include delivery to U.S. addresses only, as supplied by selected winners.
